

The Arab future (Al-Mustaqbal Al-Arabi)

Publication Standards

The Arab Future (Al-Mustaqbal Al-Arabi) is a monthly peer-reviewed journal published in Arabic by the Center for Arab Unity Studies since 1978. It is mostly concerned with affairs of importance to the Arab world, its unity, and what affects it regionally and internationally, on various political, economic, social, cultural, environmental, scientific and technological levels. The journal arouses critical thinking, seeking to promote a scientific, rational and objective reading of the issues and files presented. It also deliberates on controversial issues from multiple points of view.

The journal is divided into different sections, each of which has its own standards and conditions for publication. All Arab researchers are welcomed, and priority is given to papers that are considered innovative, as in bringing something new, whether at the level of data and information, or at the level of methodological and theoretical approaches and conclusions.

Contributions to the journal can be made through the following sections, taking into account the publication standards:

1 - Studies: The study must meet the conditions of scientific research, in terms of methodology, rooting, innovation, relying on tangible data and facts, validity of information, honesty in quoting, and accuracy in margins and referencing in a scientific manner that covers all required information regarding the sources (whether it is a book or an article, or a report...) in coherent, clear textual and linguistic construction, far from stuffing, repetition, generalizations and selectivity, and from prejudices that are not based on knowledge and research results. The study is to include an executive summary; An introduction that comprises the main idea of the study, its objectives, the methodologies it adopts, and the questions it raises. This is followed by the body, which is divided into multi-level sections and sub-headings. At last, the conclusion which presents briefly the most important conclusions reached by the research; the size of the study (excluding footnotes or references) is to be within 6,000-7,000 words.

2 - Articles and Opinions: Articles in this section of the journal deliberate on controversial topics or hot files, in a rational and objective language, adopting a new approach that presents a different point of view or a future vision or proposal for an Arab or an international issue; providing a critical and in-depth thinking and analysis method, far from daily discourse. Articles in this section should be around 3,000-4,000 words.

3 - Books and readings: Book reviews include a presentation of recently published books, whether in Arabic or a foreign language, and critically discuss its content, shedding light on the structures of the books, the

methodologies used, and the theoretical and intellectual background that govern them. A book review should be around 1,500-2,000 words.

4 - Non-fixed sections, such as the **Conferences** section, which summarizes and critically discusses the proceedings of a scientific conference or symposium within the range of 2,500-3,000 words, or the **“Major Figures”** section, which sheds light on the intellectual works and life experiences of notable Arabs, whose works, experiences, and achievements deserve to be reviewed, honored, or criticized. The paper, in turn, should be within the range of 2,500-3,000 words.

All contributions sent to the center should be in compliance with the publishing standards set forth above, they are to be reviewed and presented to the journal’s advisory committee for approval, rejection, or modification request. The writer is notified of the advisory committee's decision within a maximum period of 4 weeks.
